

BACKGROUND

- Integrated Health System Specialty Pharmacies (HSSPs) have shown improved outcomes¹⁻³ and lower medical expenses⁴ for patients yet are largely excluded from restricted drug and payer networks. A group of HSSPs implemented a comprehensive patient care model for oncology patients.
- Much of the healthcare utilization for oncology patients peaks during the first three months of therapy, in part due to medication toxicities. Patient engagement at the onset of therapy may prevent these events, potentially improving outcomes and cost of care.
- The objective was to compare hospital utilization rates within the first three
 months of oral oncolytic therapy for patients enrolled within HSSPs to patients
 within a national network not associated with an integrated care model.

METHODS

- Retrospective observational study evaluating self-reported hospital utilization rates in HSSP patients receiving an oncology medication from January 2018 through February 2022. Patients were identified from the therapy management platform.
 - Inclusion Criteria: Adult and pediatric patients new to therapy with an oral oncolytic and enrolled in the HSSP patient management program (PMP) for a minimum of three months
 - Exclusion Criteria: Transfer patients on therapy prior to enrollment in HSSP patient management program; patients opted out of PMP
- Patients with the following ICD 10 codes were identified: brain (C71), breast (C50), colorectal (C18; C20), hematology (C91, C92, C90, C83, C85, C88), lung (C34), and prostate (C61).
- Comparator (National Network) Group: A national health insurer de-identified database of 12.6 million Medicare Advantage (MA) members was used to identify patients filling self-administered specialty oncology medications from July 2018 to December 2019. Hospital utilization event rates were identified for the first three months of therapy.
- Primary outcome: Hospital utilization rates during the first three months of therapy, which were calculated for the HSSP group from patient report

RESULTS

From the HSSP group, 2730 patients meeting the inclusion criteria were identified. Of these patients, 9% (n=247) reported hospital utilization, compared to 22% (1994/8960) in the national network group.

CONCLUSIONS

- The hospital utilization rate of HSSP oncology patients within the first three months of therapy was lower than that
 of a national network, enrolled in standard specialty pharmacy patient management.
- The utilization rate calculated from claims data in the national network demonstrates the risk of avoidable medical events in the first three months of therapy.
- An integrated care model with close clinical monitoring and follow-up during this time period may help reduce the risk of medically avoidable events and overall total healthcare expenditures, which peak at the start of oncology therapy.
